By signing below, Customer authorizes PacifiCorp, doing business as [Rocky Mountain Power/Pacific Power] (“PacifiCorp”), to release at the request of the owner, operator and/or maintenance provider of the building in which Customer resides or operates a business (collectively with their respective employees, agents and representatives, my “Landlord”), monthly kilowatt-hour consumption data corresponding to the account(s) identified above for the purposes of a nationwide energy efficiency benchmarking effort, which is intended to lead to an overall reduction in energy consumption and reduced greenhouse emissions.

I understand that such information will be provided to Landlord using Portfolio Manager (as defined below) monthly on an aggregated basis with consumption data obtained from other tenants in my building and, once so aggregated, no personal identifying information remains. Also, once aggregated, the data will become publicly available information. Specifically, such aggregated information will be downloaded to the Environmental Protection Agency’s (EPA) ENERGY STAR Portfolio Manager website (“Portfolio Manager”) and made available to my Landlord and other users of the Portfolio Manager. I understand that PacifiCorp shall not be liable for any claims, demands, causes of actions, damages, or expenses arising from or resulting from any release of such kilowatt-hour consumption data pursuant this written authorization; the unauthorized use of such consumption and billing information by a third party receiving such information from PacifiCorp pursuant to this written authorization; or any actions taken by a customer-authorized third party. In all instances, I hereby waive any claims against PacifiCorp arising out of or in any manner related to the release of kilowatt-hour consumption data.

This authorization commences on the date of execution of this release and terminates the earlier of the date that Customer vacates the Address or at such time as Customer rescinds this authorization by submitting a written notice of rescission to PacifiCorp. Such cancellation will not be valid if action was already taken.
