Residential Mixed-Use Meter Certificate**

**Bonneville Power Administration
Residential Exchange Program Credit**

Under the terms of the Northwest Power Act, your residence is currently receiving or may be eligible for the Bonneville Power Administration's (BPA) Residential Exchange Program (REP) "energy credit". This credit is applied to your monthly electric bill from Rocky Mountain Power. The credit is based on your residential electrical load subject to the terms, conditions and limitations in the Northwest Power Act and BPA Customer Load Eligibility Guidelines.

As your local electric provider, BPA requires Rocky Mountain Power to obtain a completed certificate on your account at least once every ten years to certify whether your residential meter is eligible for the BPA credit. This form pertains only to the use of residential meters with loads at or above **100,000 kilowatt hours (kWh) per year**. If you have more than one meter with usage at or above 100,000 kWh per year, each meter will be treated independently; that is, a separate form needs to be completed for each meter.

Completing this form is very important. If you fail to accurately complete, sign, and promptly return the form Rocky Mountain Power will be required to remove the BPA credit from your monthly electric bill. Rocky Mountain Power may contact you after reviewing your completed certificate to ask questions and/or obtain additional information or documentation regarding your BPA credit eligibility.

Residential Classification of Exchange Load

Residential loads are generally eligible to receive REP benefits. Eligible loads would be single and multi-family dwellings, nursing and group homes, and seasonal dwellings (*e.g.*, beach houses, mountain cabins, condominiums, and motor homes/recreational vehicles used as permanent or seasonal residences in fixed locations). Facilities associated with daily residential life are also eligible for REP benefits. These include swimming pools, hot tubs, tool or equipment sheds, security, parking and outdoor area lighting, laundry rooms, and maintenance equipment.

Loads related to commercial enterprises metered through a bona fide residence are eligible for REP benefits only if the commercial activity consumes less than 50 percent (50%) of the total electrical load and is not separately metered.
