The Company submits this filing to discontinue the Schedule 196 surcharge at the end of the five year pilot period in accordance with Utah Code Ann.§ 54-20-103 and compliance with the Commission Order.

The enclosed proposed tariff sheets are associated with Tariff P.S.C.U No. 51 of PacifiCorp, d.b.a. Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405-2(D), PacifiCorp states that the proposed tariff sheets do not constitute a violation of state law or Commission rule. The tariff sheets reflect an effective date of January 1, 2022.
