Rocky Mountain Power (“the Company”) is submitting this third supplemental filing to provide the signed rights-of-way/easement documents for Anadarko Land Corporation, which supersede the signed authorization letter that was provided with the Company’s March 7, 2019 filing. The Company is also providing one state of Wyoming agreement that was inadvertently left out of the previous supplemental filings.

Attachment 1C includes the complete lists and copies of the final signed rights-of-way/easements that have been obtained for the Aeolus-to-Bridger/Anticline Line CPCN, the Ekola Flats Network Upgrades CPCN, the TB Flats I and II Network Upgrades CPCN, and the Cedar Springs Network Upgrades CPCN.

Rocky Mountain Power has provided all of the required rights-of-way documents in order to receive approval to lift the conditional aspect of the CPCNs and does not anticipate any additional supplemental filings for rights-of-way documentation for these CPCN projects.
