## Residential Service - Time-of-Use Pilot Schedule 19

### Available

For up to 500 customers on a first-come, first-served basis in all territory served by the Company in the State of Wyoming.

### Applicable

To single-family residential Customers for all electric service for domestic purposes when supplied at one point of delivery.

When a portion of a dwelling is used regularly for business, professional or other gainful purposes and 50 percent or more of the electrical energy supplied to that dwelling is being used for residential purposes, the premises shall be subject to this or other residential rates. If 50 percent or more of the electrical energy supplied to the premises is used for other than residential purposes, the premises will be classified as non-residential and electric service shall be provided under the appropriate non-residential schedule. However, if the wiring is so arranged that the service for residential purposes can be metered separately, this Schedule will be applied to such service.

### Monthly Billing

The sum of the Basic Charge, Time-of-Use Metering Fee, and Energy Charges. All Monthly Billings shall be adjusted in accordance with Schedules 93, 95, 191, 197, and 198.

### Monthly Billing (continued)

#### Minimum Charge

The Basic Charge. A higher minimum may be required under contract to cover special conditions.

#### Time-of-Use Periods

On-Peak: 7:00 a.m. to 9:00 a.m., and 5:00 p.m. to 11:00 p.m., all days.  
Off-Peak: All other times.

### Guarantee Payment

The Company shall guarantee against excessive increase of customer costs for the first year of enrollment in the program. If the total energy costs incurred on this Schedule for the first year exceed 10% over what costs would have been for the same period under Schedule 2, the net difference, Guarantee Payment, will be credited on the customer's bill following the end of the first year of service under the program. No Guarantee Payment shall be given if Customer terminates service on the program before the end of the first year on the program.

### Term of Service

Customers requesting service under this pilot program agree to remain on the pilot for one year. Customers will have the option to opt out of the pilot after this date by notifying the Company. Service will continue under this schedule until Customer notifies the Company to discontinue service or this schedule terminates.

### Continuing Service

Except as specifically provided otherwise, this Schedule is based on continuing service at each service location. Disconnect and reconnect transactions are subject to the provisions set forth in Rule 3, Section VI of this Tariff.

### Rules

Service under this Schedule is subject to the General Rules contained in the tariff of which this Schedule is a part, and to those prescribed by the Wyoming Public Service Commission.
