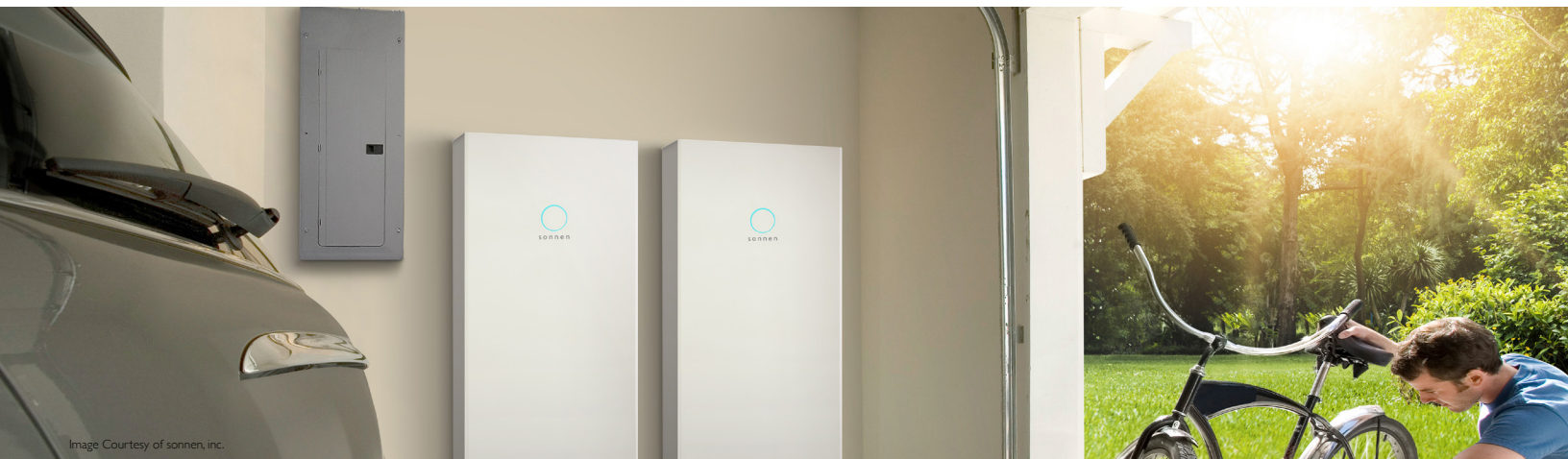

INTRODUCING WATTSMART BATTERIES

At Rocky Mountain Power, we are committed to sustainable energy, including developing innovations for the energy grid of the future. With the new Rocky Mountain Power Wattsmart Battery Program, we are connecting with customers who want to take the journey with us to a more sustainable energy grid.

HOW DOES IT WORK?

This program uses renewable energy stored in customer-owned battery systems. When you participate, your battery will be made available to Rocky Mountain Power to help manage energy on the electric grid. At the same time, your battery storage system may serve as back-up electricity to your home or business, in case you ever need it. By participating, you will earn an upfront enrollment incentive and ongoing bill credits while helping to keep electricity prices in Utah among the nation's lowest.

WHO IS IT FOR?

This is an exciting program for trailblazing Rocky Mountain Power customers in Utah who purchase and install a qualifying battery storage system on or after December 1, 2020. Customers should work with their contractor to install a qualifying battery and ensure all equipment is connected and meets program requirements for participation. BENEFITS OF PARTICIPATING

- Upfront cash for program enrollment up to \$400 per kW (based on battery capacity available for discharge) plus an annual bill credit.
- Ongoing annual bill credit of \$15 per kW starting in year two of the program. The annual credit will be divided and applied equally to your monthly bill.
- Battery system available for back-up electricity if needed. *Note: your specific installation should be designed by your contractor to provide back-up power.*
- Support efficient and effective use of renewable energy.
- Contribute to a sustainable energy future.
- Help keep electricity costs in Utah among the lowest in the nation.
- Easy online application and approval process.

INCENTIVES ARE BASED ON BATTERY SIZE

	Enrollment Incentive (One-time upfront cash payment)	Participation Incentive (Monthly bill credit)
Qualifying Batteries	\$400 per kW (Based on 4-year commitment)	\$15 per kW per year
Example Incentive (Based on 6 kW battery installed)	$6 \text{ kW} \times \$400 = \$2,400$	$6 \text{ kW} \times \$15 = \90 annual bill credit (\$90 / 12 = \$7.50 monthly bill credit)

PROGRAM ELIGIBILITY

- Qualifying Rocky Mountain Power customers must be on Electric Service Schedule 135, 136, or 137 to be eligible.
- All equipment is installed, connected, and meets all program requirements for participation on or after December 1, 2020.
- Battery must be charged by customer onsite solar system.
- Incentive capped at 70% of battery equipment costs.
- Customer owns premise where equipment is installed.
- Allow Rocky Mountain Power to control and dispatch battery
 - Customer must have customer generation meter.
 - Must have constantly working and reliable Internet connection and Rocky Mountain Power communications verification.
- Minimum 4-year contract commitment and early termination rules:
 - If customer has a qualified battery already installed and wants to enroll in the program, the upfront enrollment incentive does not apply.
 - Customer must repay prorated incentive for early termination.
 - Customer agrees to provide Rocky Mountain Power with 30 days advance notice of a sale of the home or business where the equipment is installed.
 - New owner may assume the agreement in writing.
- Customer monthly bill credit cannot exceed monthly energy usage charge on bill.
- Terms and Conditions document must be signed by both installer and customer

HOW TO PARTICIPATE

To see if this program is right for you:

- Visit RockyMountainPower.net/battery to read the Rocky Mountain Power Wattsmart Battery Program rules and requirements.
- If you're interested in partnering with us, work with a qualified installer of your choice to evaluate your options.
- Submit your Customer Generation application for review and approval.
- Once approved, have a program-eligible battery connected with a customer generation meter.
- Submit a Wattsmart Battery application for participation and associated incentives.
- Adhere to program rules and requirements.

After that, Rocky Mountain Power will:

- Verify your applications have been received and approved.
- Confirm ability to communicate with and dispatch the battery.

After installation and verification, you will receive a program incentive check and be enrolled in ongoing bill credits with your active participation.
