## INSTANT INCENTIVES

If you're a Rocky Mountain Power business customer in Utah who likes to take maintenance into your own hands, we're now offering Wattsmart ${ }^{\oplus}$ Business instant incentives for LED lighting when purchased at a participating lighting distributor. So, now as lamps burn out, it's more affordable than ever to replace them with energy-saving options.

LED lamps on a qualified products list will use 25 to 60 percent less energy than incandescent lighting. This can add up to big bucks considering about 20 percent of commercial electricity use is attributed to lighting.
